**PARTICIPANT'S SIGNATURE RATIFIES THIS AGREEMENT TO PLAY**

**1. Volunteer Participation.** I acknowledge that I have agreed to voluntarily participate in the above soccer league and its associated activities and have read and agree to the League's By-Laws and Rules of the Game.

**2. Assumption of Risk.** I am aware of the possibility of physical injury with soccer play or practice and, in consideration for the League accepting me as a player, I acknowledge that I am in good physical health, able to play and have consulted a medical professional prior to any physical activity. I am voluntarily participating in any League activities and by doing so, acknowledge and understand that there may be potential damage to my person and property or anyone associated with me and hereby agree to accept any and all risks of injury or death, and verify this statement by signing herein and/or playing, participating with the League in its activities.

**3. Medical Care.** In the event I am injured in any League activity, I hereby authorize the League, its officers, other players, referees or any other individual to arrange for and consent on my behalf to emergency medical care and treatment, and to consent to medications for pain and other conditions as prescribed by medical personnel attending to me. I am fully responsible for payment of any medical charges or expenses regardless of any personal or League insurance coverage and I agree that the League shall not be liable for any medical charges or expenses incurred on my behalf and indemnify the League for any charges or expenses that may incur.

**4. Release.** I hereby agree that I, my assignees, heirs, guardians, and legal representatives will not make a claim against, sue or attach a claim against the League or any other organizations or committees affiliated with, for any accidents, injury, death or damage resulting from my participation (active or passive negligence, misconduct or otherwise) that may be caused by any officer, referee, volunteer, agent or fellow participant of the League from any claims, demands, causes of actions, damages, cost, expenses, attorney fees, losses, or liabilities, in law or equity of every kind and nature whatsoever (Claims) arising out of or in connection with my participation. I hereby release, hold harmless and indemnify the League (its officers and fellow participants) and all organizations and committees affiliated therewith, from all actions, claims or demands that I, my assignees, heirs, guardians and legal representatives now have, or may hereafter have, for injury or damage resulting from my participation in any League activities; soccer play or practice.

**5. Knowing and Voluntary Execution.** I have carefully read this Agreement and fully understand its content. I am aware that this is a release of liability and a contract between myself and the League and/or its affiliated organizations and officers and signs it of my own free will. I acknowledge my personal liability in any participation and accept this liability in full.
